

Restitution

Restitution is financial compensation paid to a victim by the offender for crime-related financial losses. The prosecutor requests an order for restitution from the judge. Victims of crime, their families, and certain others may request and receive restitution.

Restitution may be requested for crime-related financial losses including:

- ✧ Counseling
- ✧ Lost Wages
- ✧ Medical Bills
- ✧ Property Damage
- ✧ Stolen Property
- ✧ Vehicle Damage

Restitution is collected and distributed to victims by the Probation Department, the California Department of Corrections and Rehabilitation (CDCR), or the District Attorney's Office.

Victim Advocacy

The Victim Services Division has specially trained and experienced Advocates to work with victims, witnesses, and their families throughout and beyond the criminal justice process.

This program is designed to reduce the trauma that victims and witnesses may experience following a crime. We seek to make the criminal justice system more understandable, accessible, and responsive to the concerns of victims and their families.

Victim Advocates work to ensure that crime victims and their family members are provided the services and information necessary to be an integral part of the criminal case process and to ensure victims are treated fairly and that their voices are heard.

Advocacy services may include:

- ✧ Court Escort and Support
- ✧ Orientation to Criminal Justice System
- ✧ Assistance with Victim Compensation Applications & Claims Process
- ✧ Referrals to Community Resources
- ✧ Victim Impact Statements
- ✧ Case Status Updates
- ✧ Property Return

Victim Compensation Program

If you or your family has sustained physical or emotional injury as a direct result of a crime, you may be eligible to receive financial assistance through the California Victim Compensation Board (CalVCB), managed through our local Victim Compensation Unit.

If a person meets eligibility criteria, CalVCB can compensate many types of crime related expenses when the costs are not covered by other sources.

Among the eligible crimes are:

- ✧ Domestic Violence
- ✧ Child Abuse
- ✧ Sexual and Physical Assault
- ✧ Homicide
- ✧ Robbery
- ✧ Drunk Driving
- ✧ Vehicular Manslaughter

The following losses may be covered by the Program:

- ✧ Medical and Dental Treatment
- ✧ Mental Health Services
- ✧ Income Loss
- ✧ Loss of Support for Dependents
- ✧ Home Security
- ✧ Residential Crime Scene Cleanup
- ✧ Funeral and Burial Expenses
- ✧ Job Retraining
- ✧ Relocation

Losses NOT covered under CalVCB include:

- ✧ Personal property losses, including cash
- ✧ Pain and suffering

In addition to being a victim of a qualifying crime, applicants must meet other criteria, including:

- ✧ Reporting the crime to law enforcement or Child Protective Services
- ✧ Cooperating with law enforcement and the CalVCB Guidelines
- ✧ Not having participated or been involved in the crime
